Qualifications and Experience:

Dean Tong is a nationally recognized author, forensic trial consultant, and subject matter expert who consults on and testifies in high-conflict divorce, child custody, abuse allegations, and parental alienation-related court cases. Mr. Tong has worked cases from all 50 States, albeit, sexual/physical child abuse, domestic violence, et al, SAID/PA, et al. Mr. Tong has tendered expert witness testimony since December 2001 in 20 States in cognitive developmental child psychology (includes child suggestibility, memory, source monitoring and source mis-attribution errors, et al), evidence-based best practices in child forensic interview methodologies, child protective investigations by CPS/Police, risk assessment sexual interest testing, SAID/PA, and potential iatrogenic/inimical psychotherapy by children's therapists in de novo high-conflict court cases. Mr. Tong has testified as a "blind or cold case" Expert Witness in a criminal jury trial from California. Mr. Tong has assisted in several "Indigency - In Forma Pauperis" cases from a dozen states and at discounted rates, and has been approved by many Judges and public defenders' offices. In Criminal and Dependency/TPR complex child sex abuse cases nationwide, Mr. Tong has worked as both a Consulting and Testifying Expert for the Defense - including Jury Trials - and closely

with the Offices of the Public Defender and Office of Public/Indigent Defense Services in Florida (JAC), South Dakota, West Virginia, Iowa, Alabama, Arizona (Maricopa County OPDS et al), Georgia, Minnesota, Texas, California, Maine, and Missouri. Courts have accepted Mr. Tong's testimony in the areas of psychology and social science; including cognitive child developmental psychology; evidence-based best practices methodology of forensic interviews of children allegedly abused, child suggestibility and memory, child protective services/police investigations, SAID/PA, and psychosexual risk assessment testing. Mr. Tong has tendered as an Expert Witness in 20 States and has testified as an Expert Witness ~80 times (criminal/civil courts). Not including Depositions, Mr. Tong has testified before Judges and/or Juries in VT, MA, RI, VA, W.VA., NC, GA, FL, AL, IA, KY, TN, ID, AZ, CA, ND, KS, MI, ME, and PA.

Mr. Tong has consulted on protracted divorce, custody and contested abuse-related (high-conflict) cases since January 1995, and has been involved in child custody/sexual abuse accusations cases since 1984. Tong has been retained as a consulting and/or testifying Expert in court cases from all 50 states as well as British Columbia, Canada and Auckland, New Zealand by parents and/or attorneys in alleged child sexual and physical abuse cases, failure to protect/thrive, shaken baby syndrome, coaching, Factitious Disorder by Proxy, and domestic violence cases. As an Expert, Civil Courts in FL, TN, GA and MI have excluded him from the Rule of Sequestration. Mr. Tong has also testified as an Expert at Post-Conviction Criminal Court Evidentiary Hearings in Florida (3.850), et al. Mr. Tong, in addition to his work involving legal cases in family, juvenile, criminal, administrative appeals and state appellate courts, has testified as an expert witness in criminal/juvenile case pre-trial "taint hearings." Mr. Tong, a former Medical School attendee (1983), is a former licensed lab medical technologist and has reviewed hundreds of ano-genital SANE reports during his career. He possesses advanced medical knowledge to be able to assist in medical child abuse court cases; including alleged FDIA/Munchausen Syndrome, Shaken Baby Syndrome, Sex Crimes Rape Kit cases, et al. And, for protective parents (usually mothers) who have lost child custody or may lose child custody in the future due to alleged false allegations of coaching or alienation, Mr. Tong has helped attorneys in many cases.

Under Contract and In Press: Dean Tong is Co-Authoring an academic book with a Clinical/Forensic Psychologist titled Parents' Pawns: Expert Advice in Navigating False Allegations and Parental Alienation which will be published around May 25, 2026. Dean Tong's third book Elusive Innocence: Survival Guide for the Falsely Accused (Huntington House, 2002) received peer-reviewed recognition in the May/June 2006 issue of The American Journal of Family Therapy in a scientific article titled Parentectomy in the Crossfire. In addition, the book was reviewed in Legal Alert published by the Florida Bar in 2002. Mr. Tong's first book, Don't Blame ME, Daddy (Hampton Roads, 1992) was groundbreaking in that it was the first published work in any commercial bookstore addressing false/unfounded child sexual abuse allegations within the dynamic of high-conflict divorces and child custody battles. Tong also contributed a Chapter in the book Child Abuse: Current Controversies published by Greenhaven Press and edited by Thomson Reuters in 2006. Mr. Tong is also Author of the paper – Pitfalls When Divorcing a BPD Spouse, and Creator of the taped series' – Sexual Allegations in the 90's and In Fear of Fathers. Dean Tong's work; and specifically his published peer-reviewed scientific journal article and third book have been cited by a bevy of psychologists within their own published works. Dean Tong is the author of a scientific peer reviewed journal article titled "The Penile Plethysmograph, Abel Assessment for Sexual Interest and MSI-II: Are They Speaking the Same Language?" published by Taylor

and Francis in their May – June 2007 issue of The American Journal of Family Therapy.
